About the Project

The inaugural launch of the To Switch project took place over Zoom, on 9-December-2020.

Present at the launch were representatives from each of the eight European partners collaborating on the project. The associate partner from Switzerland was also represented. The project itself is being navigated from within the framework of the Erasmus +, KA2.

The project aims at creating three intellectual outputs (IO) for the innovation and improvement of training processes, as well as updating trainers and professionals involved in the training of adult workers, in particular those over 50.

The project responds to the challenges posed by profound changes in the work place linked to the digitisation of work and the demand for new skills, ultimately exploring and addressing the effect this has on the growing share of senior workers in the workplace.

The urgency of supporting lifelong learning and training of mature workers is now widely recognised, as is the focus on the mechanisms and motivations for learning and the work that changes with age.

GOOD PRACTICE TEMPLATE FOR COLLECTION AND ASSESMENT, 17-February-2021

The Italian partner IRS, in collaboration with the Spanish partner UNIZAR, defined a template for collection and assessment of good practices. The template was shared and approved by the partners during the online meeting. Until May, good practices from the partners will be collected and then will be assessed. At the same time UNIZAR is analysing the most recent theoretical-methodological scientific literature on senior workers' training. The results of these activities within the Work Package 2 'Development of the framework of reference for senior workers' training' will be part of the scientific report (IOI) on a new theoretical and methodological framework of reference.

The report will also include a new conceptual and applicative framework for senior workers' training in technology rich contexts. It will be applied to the training of trainers and other operators involved in training and in the evaluation, validation and certification of acquired skills; a description of the new transversal knowledge and competence that should distinguish trainers and other occupations supporting senior workers' learning according to the adopted conceptual framework.
